### **The Maverick Board of Director(s) Position(s) and Responsibilities**

**The Board of Directors serve as volunteers . They are responsible for the overall business management of all the aquatic programs included in Mavericks Swim Association. Directors must be capable of providing direction and management to all programs without giving certain programs preferential consideration.**

**The Board consists of a President, Vice-President, Treasurer, Secretary. Other directors may head up oversight of Marketing and Promotion, Fundraising, Team Communication, Facilities Management, etc. A representative Coach from each group, although not considered a Board member is also in attendance at Board Meetings.**

**There is a monthly Board Meeting held at La Petite Baleen every second Tuesday of the month at 7-9pm. Meetings are mandatory. No more than 3 meetings per year missed are allowed. Board member must resign if unable to keep meeting availability. Occasional extra sessions are scheduled, but scheduling is flexible to meet everyone's needs.**

**Time involved can average 1 - 5 hours or more per week, depending on project involvement. There are no raises or bonuses and no one clocks your time. Your work is measured in productivity and outcome! The Board of Directors always generously appreciate all the efforts of each Board member. Positive team spirit among Board members is a common reward!**

**Decisions are made to support the vision and goals expressly written by the Board. Policies are approved that support long term decision-making that is applied equally and also help to guide and support the needs of the members within these various swim groups. (...as they filter in and out of our programs) Consistency in policy and an attitude of helping the membership to achieve their goals is vital to Board success.**

**The business skills that are an asset to the organization are typical of any organization. Examples include business management, legal, financial or accounting, book-keeping, marketing and sales, health care, non-profit management, teaching, secretarial, project management, computer skills & web site management, to name a few.**

**The personal qualities are unique to the individuals doing the work as a Board of Directors. Some descriptions include: Possessing qualities of leadership; A solutions-centered focus, the ability to remain interested in the big picture and the maintenance of the overall vision, a positive problem solving attitude, a caring fair-minded approach. Members who can work as a team player, with the ability to take on projects and follow through in a timely fashion. This is necessary due to the nature of a volunteer organization that meets and progress once a month at a meeting.**
